NOTES TO THE FINANCIAL STATEMENTS AS AT 31st DECEMBER 2023 AND 2022

1 BASIS OF PRESENTATION

The Balance Sheet and the Income and Expenditure Account have been prepared from the Club's books and records on a cash basis in accordance with generally accepted accounting principles.

2 CASH ON DEPOSIT

The €160,000 savings account is deposited with BCP-Millennium and matures on March 8, 2024, currently earning gross interest of 0.05% pa. The current rate offered by the bank is 0.2% pa.

3 ADVANCE RECEIVED FROM HMG

Advance received from Her Majesty's Government for the repair of the Estrela building.

4 CLUB MEMORABILIA

The majority of club memorabilia has been put into temporary storage in Trajouce. A number of other larger items have been lent to Lusitania Cia de Seguros SA and will also be transferred to the Trajouce warehouse. The portrait of Charles I was returned in March 2022 to the grandson of the owner and sole beneficiary of his estate. The collection of 3600 library books was transferred in April 2023 to their new owner.

5 MEMBERSHIP AND SUBSCRIPTIONS

In the current year new members joined the Club, members resigned and did not pay their subscriptions.

During 2023 there were new members, no members resigned and did not pay their subscriptions.

6 THE SALE OF LAND

The site of the Estrela building was sold in December 2017 by HMG to a property developer for \in 3,500,000. The net proceeds of the sale of the Estrela property of \in 2,100,000 were shared between the stakeholders in November 2018 after HMG deducted all the expenses they had incurred since 1995, as well as amounts retained to cover the estimated capital gains tax on the sale and a contingency fund for other potential costs. The RBC received \in 122,216 and booked this amount as revenue in 2018.

The balance due to the club after deducting the remaining costs amounts to €17,187 and is expected to be received shortly.

REPORT OF THE EXECUTIVE COMMITTEE - 2023

2023 saw a major amount of change for the Club including several new members of the Executive Committee and Fiscal Board, the implementation of advanced Membership and automated payment software, several larger events including the Coronation of King Charles III and currently underway is a full revision of the Club's Statutes and Rules.

Executive Committee With effect from 1 April 2023, both Ian Yarwood and David Wright relinquished their roles as Chairman and Vice Chairman and Jenny Byers stepped down as Membership Secretary. This left a substantial hole to fill especially given the degree of administrative change required in 2023. I then assumed the role of Chairman and Kylie Reynolds as Events Officer. I am particularly pleased with the response we have had from members to undertake new roles. Iris Holt has taken responsibility for our website content and social media and Mark Wheeler for photography. In August 2023 we co-opted onto the Executive Committee Sadik Miah as Secretary and Tony Nutt as Membership Officer.

Membership At end 2023 we had 408 members versus 397 at the start of the year. Of note, there were 71 new members in 2023 slightly behind the 86 new members of 2022 which reflected a recovery after Covid.

Finances As a Chartered Accountant, I am not ecstatic in reporting to you a small 2023 loss for the Club of €961 in my first year as Chairman. Rest assured however that we have applied prudent financial management throughout the year. The culprit I'm afraid is the cash accounting basis of preparation of the accounts. We adopt it because it is simple. It is however only allowable for small entities since it often fails dismally to give a fair assessment of financial performance of the business. Included in 2023 cash outgoings is software development expense of €2,976 which was incurred in 2022 but late invoiced in 2023. We also prepaid 2024 software licence fees of €1,246 to achieve additional discounts. Excluding these non 2023 items we have a profit for the year.

Social Events 2023 was the year of the Coronation of King Charles III hence we were able to hold three multi-society events celebrating St George's Day, The Coronation and Trafalgar Day, all very well attended. We also had a very enjoyable excursion to the Howard's Folly winery in November closely followed by a repeat of the hugely successful Classical Evening at the Gremio Literario. Consistently the Christmas lunch drew one of the larger attendances of the year with 100 members present. We should thank Kylie Reynolds for her exceptional efforts with a heavy events schedule.

AGM The 2023 AGM was held on 30 April at Hotel Baia, Cascais, Lisbon. We thank Ron Goddard for chairing the meeting and all those who attended. Thanks also go to Ian Yarwood and David Wright for their considerable contributions to the Club and to Carol Mason who for many years chaired the Fiscal Board. I am particularly pleased that the AGM recognised these contributions making all three Honorary Members of the Club.

Churchill Society The Royal British Club were welcomed once again in June as a partner of this prestigious Society.

Membership Software At the beginning of 2023 we implemented Wild Apricot membership software to automate the processes for membership and event registration and payment. We also upgraded the payment option from Paypal to Stripe in the second half year. This has involved a lot of effort in 2023 but we will see significant benefits in 2024 and beyond. I must thank John Hughes for the exceptional contribution he has made in taking responsibility for this.

Social Media We have created new roles to maintain and expand the content of our website, Facebook pages and a new YouTube channel in the year. Thanks go to Iris Holt for taking the initiative for this and to Mark Wheeler who has professionalised the photographic content.

Corporate Sponsors Special thanks to all our Corporate Sponsors for their continued support. I am expecting that in 2024 my own time will be free of the administrative burden of 2023 hence focused more on improving benefits for members with Sponsors and reciprocal clubs.

The Fiscal Board's responsibilities are to oversee the Club's accounting, to express an opinion on its Financial Statements and to verify that the Club is being managed in accordance with the law, its Statutes and Rules.

In relation to Financial Statements, though we recognize that the cash accounting system the Club has always used causes a skewing of results from year to year, we are satisfied that for 2023 those results are properly recorded and that the Club ended the year in a sound financial state.

As the Club Chairman's Report clearly states, the Statutes and Rules governing the Club's activities have fallen behind the reality and requirements of current operations. The Fiscal Board is aware of, and involved in, the process the Chairman has set in train to modify those Statutes and Rules for presentation to members in an EGM later this year. So, while we cannot say that the management of the Club has been in accordance with existing Statutes and Rules, we can say that deviations have either been considered as being unavoidable or were minor and not harmful to the health or repute of the Club.
